DECLARATION OF SUNG B. PARK

I, Sung B. Park, declare as follows:

1. I am an attorney at law, licensed to practice in the State of California and admitted to practice in the Ninth Circuit. I have been appointed, pursuant to the Criminal Justice Act, as the attorney representing Mr. Sutcliffe in the above-entitled matter.

2. All the briefing has been completed in this case. An oral argument is set for February 5, 2007 in Pasadena, California.

3. I have just recently accepted employment with the Department of Homeland Security. Since the projected start date for my new job is February 20, 2007, I will be able to represent Mr. Sutcliffe at the oral argument. However, since I will not be able to continue my representation of Mr. Sutcliffe once I start my employment at the Department of Homeland Security, I need to be relieved from my representation of Mr. Sutcliffe after the oral argument.


4. I discussed my situation with Ms. Gail Ivens, the Administrator of the CJA Appellate Panel for the Central District. We attempted to search for a panel attorney who might be willing to take on the appointment in this case. However, we were not able to find anyone. Thus, I

respectfully request the Court to relieve me as counsel of record for Mr. Sutcliffe in CA No. 04-50189 and appoint a new counsel as the Court deems appropriate.

5. Mr. Sutcliffe is currently out of custody on supervised release.
